## RESOLUTION NO. 2015-04 CMH FINANCING

#### A RESOLUTION

AUTHORIZING THE ISSUANCE OF A NOT EXCEEDING \$500,000.00 NOTE, SERIES 2015, OF THE CITY OF REDFIELD, SOUTH DAKOTA; AUTHORIZING THE SALE OF SAID NOTE; PRESCRIBING THE TERMS AND CONDITIONS UNDER WHICH THE NOTE MAY BE ISSUED; PROVIDING FOR THE FORM OF NOTE; PROVIDING FOR THE PAYMENT THEREOF; AUTHORIZING CERTAIN OFFICIALS OF THE CITY TO DETERMINE CERTAIN MATTERS RELATING TO THE NOTE; AND OTHER MATTERS RELATING THERETO.

BE IT RESOLVED, BY THE CITY COMMON COUNSEL OF THE CITY OF REDFIELD, SOUTH DAKOTA, AS FOLLOWS:

<u>Section 1.</u> <u>Definitions.</u> Unless the context shall clearly indicate some other meaning, the terms defined in this Section shall have, for all purposes of this Resolution, the meanings hereinafter specified, with the definitions equally applicable to both the singular and plural forms and vice versa. The term:

"<u>Authorized Officers</u>" shall mean any one or more of the following: Mayor, President of the City Council or Finance Officer.

"Business Day" shall mean any day of the week other than Saturday, Sunday or a day which shall be in the State or the state in which the Principal Office of the Trustee is located a legal holiday or a day on which banking corporations are authorized or obligated by law or executive order to close.

"City" shall mean the City of Redfield, South Dakota.

"Code" shall mean South Dakota Codified Laws.

"Constitution" shall mean the Constitution of the State of South Dakota, as amended.

"Counsel" shall mean the Common Counsel of the City.

"Enabling Act" shall means collectively South Dakota Codified Laws chapter 9-25 and 6-8B.

"Note" shall mean the Note, Series 2015, in the aggregate principal amount of not exceeding \$500,000.00 authorized to be issued pursuant to this Resolution.

"Owner" shall mean the person or entity in whose name the Note is registered.

"Principal Office" shall mean the principal office of the Finance Officer.

"Resident Attorney" means an attorney actually residing in the State and duly licensed to practice therein

"Resolution" shall mean this Resolution.

"State" shall mean the State of South Dakota.

<u>Section 2.</u> <u>Findings and Determinations</u>. The Council hereby finds and determines:

- (a) That it is a necessity to issue a Note in a principal amount not to exceed \$500,000.00.
- (b) That the uncollected taxes for the City are \$1,157,979.16.
- (c) That the Note does not exceed 95% of the uncollected taxes.

<u>Section 3.</u> <u>Authorization</u>. The Council does hereby authorizes the issuance of a Note in accordance with the Enabling Acts upon such terms determined by the Authorized Officers in a principal amount not to exceed \$500,000.00 note (the "Note").

<u>Section 4.</u> Form. The Note shall be issued as a fully registered Note designated the "City of Redfield, South Dakota Note, Series 2015" and shall be substantially in the form set forth in Exhibit A.

<u>Section 5.</u> <u>Execution and Delivery of Note; Disbursement of Funds.</u> The Note shall be executed by the Authorized Officers in accordance with the Enabling Act and deposited into the general fund.

<u>Section 6.</u> <u>Authority to Execute Documents</u>. The Council hereby authorizes the Authorized Officers to execute such certificates, documents and instruments as necessary to effect the issuance of the Note.

Section 7. Sale. The Authorized Officers are authorized to negotiate the sale and placement of the Note.

<u>Section 8.</u> <u>Severability.</u> If any one or more of the provisions of this Resolution should be determined by a court of competent jurisdiction to be contrary to law then such provisions shall be deemed to be severable from all remaining provisions and shall not affect the validity of such other provisions.

Section 8. Effective Date. This Resolution shall become effective 20 days after publication, as provided by law.

This Note is issued pursuant to and in accordance with the Constitution and laws of the State of South Dakota; Chapter 9-25 and Chapter 6-8B of the South Dakota Codified Laws; and the Resolution authorizing the issuance of this Note duly adopted by the governing body of the City (the "Resolution").

IT IS HEREBY CERTIFIED AND RECITED that all acts, conditions and things required by the Constitution and laws of the State of South Dakota to exist, to happen, and to be performed precedent to or in the issuance of this Note exist, have happened and have been done and performed in regular and due time, form and manner as required by law; that provision has been made for the levy and collection of ad valorem taxes sufficient to pay the principal of and interest on this Note as the same shall become due and payable; and that the amount of this Note, together with all other indebtedness of the City does not exceed the applicable limitation of indebtedness under the laws of the State of South Dakota.
