CONSTRUCTION TO CONTINUE

SUBJECT: Water and Sanitary Sewer Replacement
TO: Residents of the City of Redfield
FROM: Helms & Associates/City of Redfield

H&W Contracting, LLC of Sioux, SD shall continue the Contract for Water and Sewer Replacement in your area. Trenchless sewer rehabilitation has already begun, with blocks requiring excavation crews in your area tentatively starting **May 1, 2023** (subject to change due to weather conditions & road restrictions).

Initial work will include: replacement of existing sewermain, watermain, along with water/sewer services typically replaced immediately following the mainline installation and connected at the property line with a new curb stop or cleanout.

Schedule: 5/1 thru 10/22

- **Mill Asphalt Roads**
- **Setup Temporary Water**
- **Locate Utilities**
- **Begin replacement of Sewer/Water W 6th Ave. and W 3rd St. (4 weeks)**
- **Start Sewer/water on W 3rd Ave and W 1st St (3 weeks)**

If you have a sprinkler system. Make sure that the sprinkler heads are marked with a flag (typically white).

Homeowners should expect temporarily blocked streets while the crews are working during the day. Driveways may be blocked temporarily as the work is being completed. If you are blocked into your driveway please call the following numbers prior to attempting to approach the crew working.



Work in your area will take a few weeks but access to your driveway/alley should only be temporarily disturbed.

Temporary water will be required to complete the project. Temporary water is water delivered by above grade small diameter pipe. Homes are typically connected via an outside hose bib. If you have an exterior water spigot that is not connected inside please be sure to notify City Hall. If you have any issues with water supply please notify the above contacts. Temporary water may result in reduced pressure and flow but should still be enough for normal use. If not please notify the above contacts.
