# Ordinance No. 08-2019 City Park and Recreation Board

## An ordinance Amending Part of Chapter 2.24 City Park and Recreation Board of the Redfield Municipal Code:

### 2.24.030 Appointment--Terms.

Upon the final adoption and publication of the ordinance codified in this chapter, the mayor with the approval of the governing body, shall appoint six members to the city park and recreation board, each of whom shall be a resident and freeholder of the city, or the surrounding area. One such member shall be appointed for one year, two for two years, one for three years, and thereafter each appointment shall be for three years. Such appointees are to hold office until their successors are appointed and qualified. The seventh member of the board shall be the city councilman responsible for city parks and recreation.
