## A RESOLUTION APPROVING ORDINANCE 2021-03

## FOR THE CITY OF REDFIELD IMPLEMENTING ZONING REGULATIONS FOR MEDICAL CANNIBUS DISPENSARIES.

AT A MEETING OF THE JOINT ZONING COMMISSION AND REDFIELD CITY COUNCIL OF REDFIELD, SOUTH DAKOTA, HELD ON SEPTEMBER 7, 2021, the Zoning Commission of the City of Redfield, South Dakota does hereby find as follows:

WHEREAS, the State of South Dakota permits the sale and consumption of medical cannabis pursuant to SDCL 34-20G;

WHEREAS, pursuant to SDCL 34-20G-58, local municipal government may enact ordinances or regulations governing the time, place, manner and number of licensees operating within its jurisdiction;

WHEREAS, the Zoning Commission has reviewed the Proposed Ordinance 2021-3, AN ORDINANCE ENTITLED, AN ORDINANCE TO AMEND SECTION 17.40.020, "Permitted Principal Uses and Structures" [HIGHWAY COMMERCIAL DISTRICT (HC)]; SECTION 17.36.020, "Permitted Principal Uses and Structures" [COMMERCIAL DISTRICT (C)]; CHAPTER 17.04 "General Provisions,"; SECTION 17.20 "District Regulations of General Application"; and SECTION 17.08, DEFINITIONS of the Zoning Ordinances of the City of Redfield, in accordance with SDCL 11-4, 1967 and the amendments thereof, and for the repeal of all resolutions and ordinances in conflict therewith, which sets forth amendments to Chapter 17 - Zoning of the Redfield Municipal Code;

WHEREAS, said Ordinance is deemed necessary to control the manner of operation in which medical dispensaries shall conduct business within the municipal boundaries of the City of Redfield, is necessary for the health and safety of its community and further require compliance with state laws and regulations related thereto.

NOW, THEREFORE, BE IT RESOLVED by the Zoning Commission of the City of Redfield, South Dakota, that the Commission does hereby approve Redfield City Council Ordinance 2021-03 and refers said Ordinance to the Redfield City Council for adoption thereby amending the existing Zoning regulations within the Redfield Municipal Code.
