ORDINANCE NO. 01-2023

An Ordinance of the City of Redfield, SD, Amending Title 5 – Business License, Taxes, and Regulations, Chapter 5.32 Intoxicating Liquors.

BE IT ORDAINED by the City Council of the City of Redfield that Title 5 of the Code of Ordinances of 23CITYCO.MARCH20

the City of Redfield is hereby amended by adding new Section 5.32.090 and 5.32.100 as follows:

5.32.090. Off-Sale Licenses.

- A. No off-sale license may be issued or renewed to the same licensee or the licensee's transferee if the license has not been actively used during the twelve months preceding the date of the current application. For purposes of this section, the term, actively used, means that the licensed premises was open to the public during regular business hours for the sale of any alcoholic beverage for consumption off the premises where sold for at least sixty days during the preceding twelve months.
 - B. The effective date of the ordinance codified in this chapter shall be January 1, 2024.

5.32.100: Other Laws

If the State of South Dakota adopts any stricter regulation governing alcohol licenses than that set forth in this Chapter, the stricter regulation shall control the establishment or operation of any alcohol license in the City of Redfield.

BE IT FURTHER ORDAINED that the remainder of Chapter 5.32 Intoxicating Liquors as well as the remainder of Title 5 – Business License, Taxes, and Regulations, of the Redfield Municipal Code shall remain unchanged and in full force and effect.
